Some information items that have accumulated:

The Departmental Curriculum Committee proposes that Chairman Creel request of the Humanities Department that they allow the following changes to be made in the list of courses in Religion which may be taken as substitutes for basic Humanities to meet the UC requirement:

- (a) Omit RN 362 (3440) RELIGION AND THE MODERN MIND
- (b) Add
 - (1) RN 464 (4494) IMAGES OF MAN IN THE WESTERN TRADITION: HISTORICAL ROOTS
 - (2) RN 465 (4495) IMAGES OF MAN IN THE WESTERN TRADITION: MODERN EXPRESSIONS
 - (3) RN 321 (3340) RELIGIONS OF SOUTH ASIA

The Committee also proposes that RN 464 and 465 (4494 ϵ 4495) be renumbered in the 300's (3000's).

Finally, the Committee proposes that RN 407 (4520) Medieval Christian Thought be re-titled Medieval Religious Thought, and that the course description be revised to suit the new title.

PROPOSAL FOR PROFESSIONAL RESPONSIBILITY POLICY

Back ground.

The Chairman indicated his desire to have guidelines approved by the Department for allocation of faculty members' professional activity. Quarterly faculty activity assignments and reports must be prepared. In addition, there is the matter of equity, or some assurance that the responsibilities carried out by each member of the department will be roughly equal.

The curriculum committee has developed the following general guidelines as common points of departure or reference for chairman and faculty consideration. It is also understood that the Chairman will work out variations with each faculty member.

Proposed Policy Guidelines:

a) That ordinarily each full-time budgeted member of the department, except chairman, teach two courses per quarter or 24-27 quarter-credits of courses during the nine-month academic year. That teaching thus should constitute 67-75% of the regular professional activity.

For purposes of this policy, it is suggested that the normal or standard course be defined as a 4-credit class, meeting 3 or 4 times per week, with one section, having 35-40 students enrolled, and that this course not be one taught by the particular instructor for the first time. Such a course would be considered equivalent to 33.3% of the faculty member's quarterly professional activity.

In determining whether more or less time should be assigned, the chairman might consider such factors as numbers of students, type of required assignments (papers and essay examinations), whether or not a reader/grader will be available, whether the course is being offered in duplicate sections by same instructor, whether course is being taught by the particular instructor for the first time or otherwise involves substantial fresh preparation.

b) That ordinarily each full-time budgeted member of the dpeartment be assigned 20-25% of professional time to research.

That such research is expected to yield results that can be shared with fellow-professionals in the field in such tangible form as publications, manuscripts completed, papers read, or symposia and colloquia conducted. That each quarter the Chairman take into account the extent of each faculty member's research time to be assigned for the coming quarter. That in the event such research products are absent or negligible, the chairman may assign little or no research time for the coming quarter.

- c) That each full-time budgeted member of the department ordinarily engage in administration or professional service activities to the extent of 5-15% of his professional time.
- d) That the chairman weigh the interests and desires, together with past performance of each faculty member, and needs of the department before making quarterly assignments.
- e) That the chairman himself feel obliged to teach no more than one course per quarter, (25-33% of time), in view of likelihood that he will expend upwards of 50% of time in administration, and may well expend an additional 25% of time in research and public service.

That the chairman have responsibility for administration of department during summer quarter, but not be obliged to teach.

Thus, if anticipated income is received, we can get through the year at the modest level to which we have become accustomed. Any major emergencies would be difficult to respond to.

- 1. We do not have budget information as yet. What pecuniary recognitions of merit materialize will be communicated when known.
- 2. The official academic year is September 9 to June 8. I calculate that 9-month faculty will receive a check for 4 days (=40%) on September 22.
- 3. Schedule of departmental meetings -- (WEDNESDAYS AT 3:30): 9/27, 10/4, 10/25, 11/8, 11/29. The following should be entered on your calendar also in the "maybe" category; we may be especially pressed early in the quarter if traditional October catalog deadline prevails: 10/18, 11/1, 12/6. Definitely we will not meet on 10/11, 11/15 or 11/22.
- 4. The meeting on October 4 (noted above) will be with Dean Charles Sidman, to discuss our work, our problems and our hopes. In the weeks that follow each department will present at budget hearings in the Dean's office its proposals for the following year, and the Dean will undertake to secure resources for the resulting college budget proposal.
- 5. I do not presently anticipate a formal meeting during "registration" week, but I think our subsequent labors will be well facilitated by some informal gatherings.
