A WORKING MODEL FOR COURSE WORK IN A MASTER'S PROGRAM FOR AN INTERDISCIPLINARY HUMANITIES DEGREE

Focus: The Human Image in the 20th c.

Assumptions:

- 1) This degree program entails a thesis by means of which the student would narrow the general focus of the human image in the 20th c to apply to a specific subject; e.g., "The Labyrinthine World: Kafka and 20th c. Aloneness."
- 2) 15 hours of the required 45 hours would be used for independent study, electives, and/or thesis research, leaving a course load of at least 30 hours, to be spread out over three quarters at the discretion of the student and his advisor.
- Certain courses, not offered now by various departments, would be constructed and offered by those departments.
- Breaking the total program into components, the specifics would be: 3 courses in literature (the range encompassing Spanish, French, English, German and American -- the expectation would be that a student choose which of the national literatures to focus upon and take the three literature courses in that area); 2 courses in history; 1 course in religion; 1 course in philosophy. Total (usually): 30 hours.

RE: Curriculum in Religion in America

(ITEM 2C)

At our March 5 meeting we decided to put all our eggs in one basket, that of courses in General Education. Here are two concrete steps we propose, in chronological order.

- (1) Advertise REL 3322 as "The American Religious Experience" in *Alligator* before advance registration in April or May. Do same during registration and drop/add this Fall. Need money!
- (2) Propose new course this Fall, "Sects, Cults, and Society," for general ed. credit in Social Sciences. If approved, that course would appear in catalog for 1980-1981. However, we might be able to offer it in Winter or Spring, 1980.

Our strategy is to create a market first. In time, all being well, we can turn attention to (a) Religion courses in the American Studies curriculum, (b) advanced departmental courses in Religion in America, and (c) our participation in the new Center for Studies in American Culture.

This is a report of today's meeting. It will be augmented by Dennis's inquiries as to the specific character of the new three-Quarters requirements in Social Sciences.

SUBJECT: Report of Sub-committee on General Education (consisting of Professors Hiers, Mesch, Owen, Thursby, and (ex. of.) Creel).

Pursuant to its commission by the Department meeting of April 6, the Committee met this date (4/20/79) to:

(a) discuss possible new 2000 level courses.

(b) consider the status of intro. course(s).

(c) determine and articulate pending questions.

In regard to questions (a) and (b), the subcommittee considered a fairly wide range of issues and possibilities. By consensus and/or vote, the subcommittee reached the following conclusions:

That all department faculty should, in one way or another, be involved in teaching general education course(s) at the 2000 level as part of their regular tour of duty. (Uncanimous).



The following courses were considered as possible prospects for general education at the 2000 level, but no decisions were reached:

REL 2001 Religion and Human Experience

3202 Survey of Biblical History and Religion

3321 Religions of the West

3322 Patterns of American Religion

3340 Religions of South Asia

3600 Introduction to the Study of Judaism (Prof. Mesch indicated that this course now might be taught as "Intro. to Judaism.")

3) On alternative motions:

That all faculty be involved in teaching REL 2001 ("Religion and Human Experience"), and that this be the one course offered at the 2000 level: one for.

That additional courses be created at and/or moved to the 2000 level, and that department faculty involvement in general education at the 2000 level be through teaching one or more of these courses: two for.

There were two abstentions, one being on the part of the ex officio member of the subcommittee.

- 4) It was judged that the subcommittee defer consideration as to which courses might be moved to the 2000 level until further instructed by the full Department.
- 5) A motion was made that a course entitled "Introduction to Christianity" be created at the 2000 level, relationship to the present REL 3321, "Religions of the West," being left to further consideration. Three for; two abstentions.

Some issues discussed in connection with these questions were as follows:

What reasons are there for proposing to involve all faculty in teaching the same 2000 level course: better communication among faculty, distributing the responsibility for large sections more fairly, introducing prospective majors and other repreaters to a wider range of department faculty, the benefit of all (or some substantial number of) students in Religion starting from the same common experience?

Would involvement of all faculty in teaching the same 2000 level course mean a reduction in the number of other courses taught in the department during a given year?

Would "packing 'em in" to this once one course tend to draw off students from other courses causing increase in number of classes subject to cancellation for lack of minimum numbers of students?

If present 3000 level courses are changed to 2000 level, would this provide any assurance that faculty would not merely continue "doing their same old thing?" There was consensus on the point that courses taught at the 2000 level should be taught as freshman-level courses.

It was suggested that in the case of some courses, it would be just as well to "come clean" and teach more to the 2000 level since the courses are taught as introductory courses anyway. Egs: REL 3202, 3600.

On the other hand, point was raised whether the numbers of students now taking these courses at 3000 level would necessarily follow them into the 2000 level. Question also whether, in view of increased generating capacity of the 3000 level, at least such courses as had substantial enrollments at that level should not be left there.

It was noted that little attention, as such, had been given during discussion to the question how the Department could best serve the general education needs of students in the College and University. In response, it was suggested that this question would inevitably if not best be answered by the Department doing what makes most sense in terms of the interests of the Department.

It was noted that 2000 level general education courses might well, (as in the Creel proposal of August 1978) serve to introduce various tracks or series of courses within the curriculum, but that they need not necessarily do so.

The question was raised whether, for purposes of general education criteria, or otherwise, (eg., in order to limit liability of faculty for large sections) enrollment caps should not be set to various courses, including 2001.

In regard to question (c), the following additional proposals were considered worthy of transmission to the full department for further thought:

- 1) Proposal by G.T. that majors be required to take 2001, also (at the 3000 level) a course in methods of study in religion based upon the present 2010, followed then, at the 4000 level, by the senior seminar.
- Question as to whether there may be better methods for identifying Religion majors and advising same.
- Question as to possible requirement of a senior thesis.

Components and format:

- Textbook will be principally a survey of major world religions.
 Additional reading assignments will be utilized on a very limited basis.
- 2. A weekly two-hour session ("the lecture") which will focus on themes rather than particular religious traditions. Most, but not necessarily all department members would be involved in lecturing and/or offering pertinent films. Other faculty—even visitors to the campus—might also be utilized for the weekly sessions. Topics such as the following might be utilized:

Features and roles of messianic movements
Halukah in community; the role of religious observance.
The relationsof religions
Religion, Ethics and Law
Religious expressions in art and architecture
Mythology
Patterns of religious organization
Ritual
Sources of authority

Scripture
All can readily recognize that further refinement is called for.

- 3. Two additional hours of discussion section (two one-hour or one-two-hour or both?). Sections of 25-30 students would meet with a faculty member throughout the quarter for further exploration in a discussion (not lecture) format of the content of the reading and the lecture periods.
- 4. Course management: one person would coordinate the course. All'preceptors' in a given quarter would have responsibility for attending or otherwise being adequately conversant with the lectures. Each preceptor would proceed independently but there would be 'periodic consultation among the preceptors about their patterns and "results." Grading would be done by the preceptors, who are in important respects also serving as mentors for new students in the early stages of the college experience, where issues of study habits, composition, etc. may assume proportions to which we are not presently accustomed. The staff for a given term would decide (several quarters in advance!) whether there would be an assembly examination and/or sectional examinations. There should be also some comparability in assignments of papers.
- 5. Possible staffing patterns: for 9 sections of approximately 200 students.
 - (a) Each faculty member doing one section each quarter (in addition to the present pattern of two other courses, except for the course coordinator who would have one other course). Aid would be available to some extent in the form of graduate students to be assistants in instruction in other relatively large courses.
 - (b) Each faculty member doing three sections, once a year, and teaching one other course that quarter. (Again graduate students would be available to assist in other courses.)

Draft form of resolutions for discussion.

June 15, 1979

I. Focus

Resolved that the Department of Religion will have two foci of its major research, study, and teaching efforts; namely, (1) the Jewish and the Christian tradition, with special emphasis on their mutual history, their modes of interaction, and their convergence or divergence on specific religious questions; and, (2) religion in the United States.

II. Goals (in terms of content vis a vis teaching)

Resolved that the Department of Religion will have as its teaching goals the aim of enabling students enrolled in each of its courses to understand and to appreciate one or more of the following:

- 1) the main features of their own cultural or personal religious tradition;
- 2) the main features of major variant sub-traditions within their own tradition;
- 3) the main features of religious traditions other than their own with which they are likely to come into contact;
- 4) the main features of the most widely influential humanist and secularist critiques of religion;
- 5) the main features of the most widely influential contemporary reinterpretations and rational defenses of the major religious traditions;
- 6) the most prominent problems or issues arising from part- or aspectual-analyses of religion, e.g., philosophical (problem of evil, miracles, theism, apersonalism, etc.), psychological (religious aspects of the life-cycle, concepts of consciousness, numinous experience, etc.), sociological (secularization, religious demography, sectarianism, religion and the state, etc.), anthropological (social scientific theories of religion, magic, primitive categories, etc.), ;
- 7) the main features of Jewish and Christian scriptures and scriptural traditions; and,
- 8) the contemporary religious situation in the United States.
